Facility Security Protocols

Authentix manages the security of the supply chain of all products moving directly from our manufacturing and secured warehouses to our client's designated owned or vendor sites. We use strict Standard Operating Procedures ("SOPs") to define all logistics functions; this includes using secure shipping processes and partners, as well as creating Certificates of Compliance ("COCs") for each shipment.

We maintain full records of security material usage as well as the finished product production associated with those security materials. This information supports a reconciliation process that enables security material usage to be closely monitored and investigated to assure no leakage or dilution.

Authentix is recognized as a premier organization covering all requirements of International Standards for the management and competence in laboratory tests, audit processes/procedures and high security printing.

Vendor Certification

Authentix also qualifies our client's third-party vendors through a formal certification process to ensure each has minimum criteria in place to protect the security program integrity. This process can include the implementation of minimum-security requirements, initial and routine onsite compliance audits, printing enabling trials, material consumption reconciliation and the execution of contracts to ensure ongoing compliance.
